Parents assume the following responsibilities with registration:

- Monthly Tuition. Please note: if your child is withdrawn from the school after August 1st 2018, you agree to continue making monthly tuition payments until such time as another student enrolls in the child's place, or until 3 months after written notice of withdrawal, whichever comes first.
- Parents are expected to provide a healthy snack and beverage, in accordance to with EHNS guidelines, for up to 18 people, children and staff, on assigned days. The number of days is assigned is dependent upon the total number of students enrolled, not per family.
- Parents are expected to attend three mandatory parent meetings each year
- Parents are expected to be involved in the school through participation in leadership on the Nursery School Board or fundraising committees. Parents are expected to be on the board of at least one fundraising event per year, and one awareness event per year.
